### 2018 CHEMAINUS WEDNESDAY MARKET RULES

(May 23 – September 19, 2018)

The purpose of the Chemainus Wednesday Market is to provide a venue for the sale of **local and regional (Vancouver Island and the Gulf Islands)** farm produce, flowers, baked goods, sweets, and crafts. This is a make it, bake it, grow it market that operates rain or shine.

**Hours: 10:00 am – 3:00 pm**

**Location:** Parking lot, Waterwheel Park

**Season: May 23 – Sept 19, 2018 (18 weeks)**

**Set-up:** 8.00 am – 10:00 am

**Take-down:** 3:00 pm – 4:00 pm

**To be accepted as a vendor**, applicant must complete and sign the application form including:

- A statement that the applicant has read and agrees to the guidelines as laid out.
- A statement of authenticity to be signed by crafters.
- Food vendors selling products not on the Lower Risk list produced by the BC Centre for Disease Control must include an approved Temporary Food Market Application. Information available at <http://www.viha.ca/mho/food/>.
- Organic produce must be supported with a certificate.
- Have liability insurance (see below).

Only products grown or produced on Vancouver Island or the Gulf Islands are permitted. Items from wholesale sources must be limited to 10% and must relate to the products that the vendor sells. Sale of secondhand merchandise is not allowed in this market.

Items offered for sale by new artists and crafters will be juried by the Chemainus & District Chamber of Commerce. Samples or photos of arts and crafts must be submitted with all new vendor applications.

To preserve the diversity of products the **Chemainus & District Chamber of Commerce limits to four the number of vendors selling each type of product (except farm produce) on any one day**. That is, there will only be four vendors selling jewelry and four selling soaps, etc. This rule will be applied at the discretion of the Chamber staff.

**Liability Insurance:** All vendors must carry liability insurance. This will protect you from a lawsuit resulting from an accident involving your stall or product. Contact us for more information on how to get insurance if you are unsure -- there are a variety of options depending on your needs.

**Allocation of Stalls:** Normally, vendors who sign up for the full season are eligible to have the same location for the duration of the market season. We allocate stalls according to requests received with preference given to returning vendors and farms, then new full-season vendors, and then casual vendors. There are limited stalls with parking for vehicles up to 20 feet in length, and these will be given to those with mobility issues and those who sell from their vehicle. NO vendors will be permitted to park in the stalls by the museum as these must be kept available for those wishing to access the museum. There is room to park on Croft Street (there is a trail up to make it closer), or further down Willow towards Old Town. We ask that you keep the closer spaces open for shoppers.

**Set-up: 8:30 am – 10:00 am** vehicles are allowed into the “Market Area” for quick unloading into the vendors stall until 9:45 am. The vehicle must be removed before the tent and stall is set up. No vehicles are allowed in the market area after 9:45 am except those with parking space behind their tents, and late vendors must carry everything from public parking areas. **If you expect to arrive after 9:30 am**, please notify the Chamber staff to hold your spot. If you do not let us know, we may assign your spot for that day to someone on the waiting list.

**Parking** is a problem in Chemainus on market days. Eleven stall spaces have room for parking and all other vendors must park on Croft Street or further down Willow towards Old Town to ensure adequate parking for Market shoppers. Please do not park out in front of the Seniors Centre at Willow and Alder.

**Vendors** are assigned a 10'x10' space (except those with parking spots that are 10'x20') and are obliged to:

- Provide own display equipment, shelter, signs.
- Stock the stall fully before the start of the market.
- Keep the stall space and surrounding area clean; keep all surfaces clean and sanitary.
- Clearly display the name of the vendor and/or farm.
- Maintain attractive marketing and display of products.
- Ensure that all health regulations are met (see application form for details).
- Have certified weight scales.

**Products/Produce:**

- Should be appropriately packaged, containers should be clean and sanitary.
- May be sold by weight, by the bag or container, or by the piece (e.g.5 for \$2.00).
- Should reflect a true market value for similar products in our area. **Discounting, undercutting market value and dumping of produce are not allowed.**
- Should be clearly and fully labeled with all ingredients listed.
- Value-added products should carry the producer's name and address, phone number or website/e-mail.

**Market Conduct**, vendors are expected to:

- Not interfere with customers’ access to neighboring stalls or the flow of customers.
- Be polite and courteous to other vendors and the public.
- Not smoke in the market area.
- Keep pets away from the market area.
- Not use foul language.

**We reserve the right to remove vendors and their stalls from the market area** if their conduct is unreasonable or contrary to the market rules.

**Take-Down: 3:00 pm – 4:00 pm** the stall should be packed up, tent collapsed, and all items moved to the rear of the stall before the vehicle is brought in for loading. Vendors should remove and “pack out” all garbage at the end of the day. Garbage must not be put in the trash bins in Chemainus.

**Cancellations/Refunds:** If a vendor is unable to attend the Wednesday Market, he/she must notify the Chamber staff by phone at 250-246-3944 no later than 4:00 pm the Monday prior to the market. Failure to do this will lead to a warning the first time, repeated incidents may lead to suspension and/or loss of pre-assigned space. Fees are non-refundable.

**Disputes:** The Chamber staff has the authority to regulate all market activities on site. To appeal a decision made by the Chamber staff, write to: The Events Committee, Chemainus & District Chamber of Commerce, PO Box 575, Chemainus, BC V0R 1K0.
