## APPLICATIONS WILL BE ACCEPTED AFTER MARCH 1, 2024

The Chemainus Giant Street Market is a well-loved summer tradition. This is the day when Willow Street – from Victoria to Oak – is closed off and turned into a giant outdoor market. There are no restrictions on what can be sold if it is legal.

#### The Rules

- 1. All vendors are required to follow the rules. This is a rain or shine market. No refunds or discounts will be given for poor weather conditions.
- All applicants must complete and sign an application form including a statement that the applicant has
  read and agrees to the rules as laid out below and agree to comply with the terms and conditions of this
  agreement in its entirety.
- 3. Vendors are assigned a minimum 10' x 10' space. Some stalls vary in size and shape.
- 4. If you take up space beyond your allocated 10' x 10' stall you will be charged for the extra stall.
- 5. Storefront businesses located in the market area have first right of refusal and priority of site selection.
- 6. Applications must include a detailed description of ALL goods; goods not permitted are drugs, marijuana edibles or drug paraphernalia.
- 7. Vendors must provide their own display equipment, shelter, signs, and stock the stall fully before the start of the market. Once unloaded, move all vehicles away from the downtown area to ensure shoppers can find a parking space.
- 8. Vendors must keep the stall space and surrounding area (i.e., sidewalks) clean and ensure that all health regulations are met.
- 9. Vendors must ensure that the roadway is kept clear to allow access for emergency vehicles.
- 10. Vendors are expected to keep access open to neighbouring stalls and allow for flow of customers; be polite and courteous to other vendors and the public; refrain from smoking in the market area; keep pets away from the market area;
- 11. Food Vendors must abide by all current VIHA regulations and provide a VIHA permit with current decal.
- 12. Products and produce should be appropriately packaged, containers should be clean and sanitary; clearly and fully labeled with all ingredients listed; carry the producer's name and address or phone number, email address or website for value-added products.
- 13. Stalls will be allocated in the following order: Chemainus + District Chamber of Commerce members; returning vendors and then new vendors. Spaces will be assigned by the end of June.
- 14. Every effort will be made to allocate the same spot as in the previous year to returning vendors. We ask for your understanding in the event that this is not possible.

- 15. Stalls are not equipped with power.
- 16. Vehicles are allowed into the market area between 8:00 a.m. and 9:30 a.m. for quick unloading into their stall. Vehicles must be removed before the tent and stall is set up.
- 17. Vendors must park away from Willow Street. Save this space for customers. Thank you for helping us to maximize the number of customers for the market.
- 18. Don't be late! Arrivals after 9:30 a.m. may need to carry in all their products and equipment as the street will be blocked off behind barricades. Latecomers may also find another vendor in the spot and may be assigned a different stall unless you have made previous arrangements.
- 19. The stall should be packed up between 4:00 p.m. and 6:00 p.m. the tent collapsed, and all items moved to the rear of the stall before the vehicle is brought in for loading. Vendors should remove all garbage and take it with them at the end of the day. Please do not put your garbage in the trash bins in Chemainus.
- 20. All fees are non-refundable. The only exception to this is the unlikely event that the Giant Street Market is cancelled in which case the full fee will be refunded.
- 21. Public washrooms are located on Chemainus Road by the old train station, Waterwheel Square beside the Museum and at the back of the Chemainus Public Market.
- 22. We reserve the right to refuse an application from any vendor without cause. We do not expect to exercise this right except in the case of Vendors who have not followed the rules in previous years, or who behave unacceptably when dealing with Chamber staff.
- 23. Liability Insurance Please note: The Municipality of North Cowichan suggests that all vendors carry their own liability insurance.
- 24. By stating in the signed agreement with the vendor that liability insurance is suggested, we are not responsible for liability claims resulting from their actions.
- 25. If you need assistance for any situation, find a market attendant in a safety hi-vis vest to assist.
